

Notice of Information on the Data Protection Policy for Enrolment and Participation in Bosch Future Mobility Challenge 2020

This Notice of Information supplements the data protection policies for:

- Robert Bosch S.R.L.;

Robert Bosch S.R.L. (hereinafter referred to as "Bosch" or "We" or "Us") appreciates your interest in **Bosch Future Mobility Challenge 2020**.

Bosch respects your privacy

The protection of privacy during the processing of personal data and the security of all data are important concerns for us, aspects that we consider in all our processes. Personal data collected online when you register are treated confidentially and in accordance with the relevant legal regulations, particularly according to the Regulation (EU) 2016/679 of the European Parliament and of the Council of April 27th, 2016 (General Data Protection Regulation - GDPR).

Data protection and information security are included in our corporate policy.

1. The Operator

Robert Bosch S.R.L. is the operator responsible for processing your data; the exceptions are listed in this Notice.

2. Collection and Processing of Personal Data

3.1. Categories of Data Processed

We process categories of personal data, as for example: surname, forename, personal telephone number, personal e-mail address, technical background (studies and experience, work experience, known technologies, projects, contests), extracurricular experience, completed studies, currently held position.

3.2. Purposes of Data Processing and Legal Basis

Personal data are processed for the following purposes:

- 3.2.1. Validation of your expertise in order to register and participate in the above mentioned contest, as well as to communicate the participation details. The legal basis is your consent as a result of the voluntary submission of the application for registration by e-mail / registration through the platform www.boschfuturemobility.com or by ideabox@bosch.com
- 3.2.2. Response to the requests of the data subjects. The legal basis is our legitimate interest;
- 3.2.3. For security reasons. Fulfilment of legal obligations to ensure data security;
- 3.2.4. Provision and defence of our rights and interests. The legal basis is our legitimate interest.
- 3.2.5. Compliance with the applicable law.

3. Data Transfer

3.1 Data Transfer to Other Operators

Personal data is not transmitted to other operators.

3.2. (General) Service Providers

We involve external service providers for tasks such as programming, data hosting services. We have chosen the service providers based on a careful selection and we monitor their activity, at regular intervals, in particular to make sure that your personal data are managed and kept safe. We require service providers to observe confidentiality and to comply with legal regulations. Other legal entities of the Bosch Group may also be defined as service providers.

3.3. Transfer to Entities outside the EEA

Personal data are not transmitted outside the EEA, in the so-called third countries.

4. Duration of Storage, Retention Periods

In principle, for the persons who were not selected to enter the contest, the data is stored until 30.11.2019, and for the persons selected in the contest the data is stored until 30.06.2020. We also store your data as much as necessary for registration and participation in the event, and then we delete your personal data, depending on the selection made, except for those data that we must store for the fulfilment of legal obligations.

5. Security

Bosch adopts technical and organizational measures necessary to ensure adequate levels of security and to protect personal data, in particular against the risk of destruction, manipulation, loss, unintentional or unlawful modification or unauthorized disclosure or access of third parties. Security measures will be constantly improved, taking into account technological advance.

7. Your Rights

To exercise your rights, please refer to the "Operator" section. When contacting us, please make sure that the data you entered can lead to your identification as a data subject.

7.1 Right to Information

You have the right to obtain information about the processing of your personal data and to exercise your right to information about your personal data.

7.2 Right to Correction or Deletion

You may request that the incorrect data be corrected and completed or that the data be deleted if the applicable legal requirements are met. This right does not apply to any data required for tax and accounting purposes or which are subject to a legal obligation to retention.

If access to such data is not required, the processing of this data is, however, restricted (see below).

7.3 Restriction of Processing

You can request a restriction on the processing of your data, if the legal requirements are met.

7.4 Opposition to Data Processing

To the extent that we process data based on a legitimate interest, as described in this data protection policy, you have the right at any time to file an appeal against this processing for reasons that result from your special situation.

We will then discontinue the processing of your data, unless we can prove, in accordance with legal regulations, that we have valid and legitimate reasons for further processing that prevail over your rights, interests and freedoms or for the establishment, exercise or defence of proceedings in court.

7.5 Withdrawal of Consent

If you have given your consent for the processing of the data, you have the right to withdraw it, with immediate effect and if the legal requirements are met. The lawfulness of data processing before the consent is revoked remains unchanged.

7.6 Data Portability

You have the right to receive the data you have provided to us in a common, structured format that can be read by software - if technically possible - to request the transfer of that data to a third party.

7.7 Right to File a Complaint with the Supervisory Authority

You have the right to file a complaint with a supervisory authority. You can call the competent supervisory authority in your area of domicile/residence or the responsible supervisory authority in our case, respectively:
